## **NOTIFICATION**

Keeping in view the vast area and hilly terrain of the Province of Gilgit-Baltistan and in order to provide the general public and lawyers of remote stations easy access to justice, the Hon'ble Chief Judge of this Court in exercise of the powers under Rule 5 of Order III of Supreme Appellate Court Gilgit-Baltistan Rules and all other powers enabling him in this behalf, is pleased to declare all the Video Link Cells (*Diamer, Astore, Hunza & Ghizer*) of this Court to be Sub-Registries for the following purposes;

1. To receive all applications of the nature mentioned in sub article (1) of Article 76 of the Government of Gilgit-Baltistan Order, 2018 involving matters of general public importance with reference to any of the Fundamental Rights conferred by Chapter I of Part II of the aforesaid Order.
2. To communicate via video link with the office of Registrar by the senior most staff member available at a Video Link Cell/Sub-Registry regarding details of any application received under Article 76(1) of the Government of Gilgit-Baltistan Order, 2018 immediately after receiving the application.
3. To use the video link facility at a Sub-Registry for listening to any applicant or any lawyer in any case by the Court sitting at Principal Seat or other place of sitting of the Court.
